Teletherapy Informed Consent Form

l	hereby consent to engage in
teletherapy with Avalon Behavioral Health, PLC. I und	derstand that "teletherapy" includes
consultation, treatment, transfer of medical data, em	ails, telephone conversations and
education using interactive audio, video, or data com	munications. I understand that
teletherapy/coaching also involves the communicatio	n of my medical/mental information, both
orally and visually.	

I understand that I have the following rights with respect to teletherapy:

- 1. I have the right to withhold or withdraw consent at any time without affecting my right to future care or treatment.
- 2. The laws that protect the confidentiality of my medical information also apply to teletherapy. As such, I understand that the information disclosed by me during the course of my therapy or consultation is generally confidential. However, there are both mandatory and permissive exceptions to confidentiality, which are discussed in detail in the general Psychotherapy Services Agreement I received with this consent form.
- 3. I understand that there are risks and consequences from teletherapy, including, but not limited to, the possibility, despite reasonable efforts on the part of my therapist, that: the transmission of my information could be disrupted or distorted by technical failures; the transmission of my information could be interrupted by unauthorized persons; and/or the electronic storage of my medical information could be accessed by unauthorized persons.
- 4. In addition, I understand that teletherapy based services and care may not be as complete as face- to-face services. I also understand that if my therapist believes I would be better served by another form of therapeutic services (e.g. face-to-face services) I will be referred to a professional who can provide such services in my area. Finally, I understand that there are potential risks and benefits associated with any form of psychotherapy, and that despite my efforts and the efforts of my psychologist, my condition may not be improve, and in some cases may even get worse
- 5. I understand that I may benefit from teletherapy, but that results cannot be guaranteed or assured.

- 7. I understand that while email may be used to communicate with my therapist, confidentiality of emails cannot be guaranteed.

8. I understand that I have a right to access my medical information and copies of medical records in accordance with HIPAA privacy rules and applicable state law.
